How tragic when a country has a system of justice that punishes innocent law-abiding citizens and turns a blind eye toward the unlawful acts of the wicked!



Yet, should we not all be terrified? Are we not guilty? Are we not law breakers? Are we not in the class of people labeled as “wicked” (*Mark 7:20-23*)? The Holy One cannot turn a blind eye and justify the wicked. We are doomed, condemned and under the judgment of God.
